For the past 26 years, Mr. Hyon Min Choi served in the public sector, including the National Tax Service and the Tax Bureau of the Ministry of Economy and Finance.

Since Mr. Choi started his public service career at the NTS Busan Regional Tax Office in 1991, he spent most of his career focusing on national tax, obtaining a breadth of experience and a depth of knowledge in national tax. Mr. Choi was in charge of important duties at the National Tax Service, including his service as Director of the Legal Affairs Bureau of National Tax Service; Director General of the Investigation 2 bureau of NTS Daegu Regional Tax Office; Director General of the Investigation 3 bureau of NTS Seoul Regional Tax Office; Director General of the Asset Taxation Bureau of National Tax Service; Director General of the Corporate Tax Bureau of National Tax Service; and Commissioner of the NTS Busan Regional Tax Office, etc.

When Mr. Choi served as Director of the Legal Affairs Bureau, he operated an insufficient taxation prevention system including the taxation criteria and taxation dispute consultation policies as well as an insufficient taxation cause analysis system, which was designed to prevent arbitrary interpretation and application of tax law and to secure the validity of taxation and avoid an unfair infringement on the rights of taxpayers.
