Mr. Joong Sung Ahn is the chair of the Capital Markets and PE Group at Jipyong. His practice primarily focuses on Private Equity (PE), M&A, IPOs & Capital Markets, Financial Regulation, and Business Combinations. He has lectured on private equity laws and regulations at the Korea Financial Investment Association (KOFIA) for several years and possesses extensive experience and distinguished expertise in the PE sector through close cooperation with financial supervisory authorities and market participants.

In particular, Mr. Ahn provides systematic and professional advisory services for PE-related domestic and cross-border investment matters such as M&A and various legal issues arising therefrom. He possesses a wealth of experience in M&A for various domestic and international PEs, as well as diverse PE investment methods such as Pre-IPO and Mezzanine investments and exit strategies, while continuously exploring high-level theoretical knowledge and maintaining an excellent track record in advisory services. Based on his accumulated experience, he successfully provides one-stop advisory services, including step-by-step strategies and transaction structuring required for PE investment, legal due diligence on target companies, assistance in preparing and executing contracts reflecting various transaction methods, and regulatory permits related to transaction structures such as business combination filings.

He also holds annual seminars for the management departments of the Council's member firms on major PE policies, systems, and compliance, contributing significantly to enhancing the capabilities and networking of member firms. Through timely seminar topics such as "Explanatory Note on the PEF System under

the Amended Capital Markets Act regarding the Restructuring of the Private Equity Framework (2023),” “Strategies for Upgrading PE Management Infrastructure, including Internal Controls (2024),” and “Trends in the PEF System and Strategies for Improving Compliance Risk Management Systems (2025),” he has addressed various issues related to the domestic PE system. He has explored specific ways to upgrade internal control infrastructure for PEF managers, such as establishing effective internal control systems, preventing conflicts of interest, and implementing mechanisms to block employee misconduct. He has also examined recent inspection trends and key cases from supervisory authorities to provide implications for the PEF market and check specific items requiring attention in the operation and management of PEFs under relevant laws. This has helped pave the way for improving management infrastructure to enhance the credibility of the domestic PE industry and establish a sound transaction order.

Mr. Ahn passed the Korean Bar Examination in 2010 and completed the Judicial Research and Training Institute’s apprenticeship program in 2013. He served as a Public-Service Advocate at the Incheon Branch of the Korea Legal Aid Corporation, the Regulatory Reform & Legal Affairs Office of the Financial Services Commission (FSC), and the Litigation Division of the Korea Fair Trade Commission (KFTC).
